# **RESPONSIBILITIES OF BOARD MEMBERS**

The Board of Directors shall manage the business and affairs of IFNA. The Board establishes goals and assesses progress towards goals, maintains stewardship responsibility for finances, and sets policies for overall management and operation of the association. While day-to-day operations are coordinated through a management company, the Board's relationship with that company is a partnership and the appropriate involvement of the Board is both critical and expected.

## Key Duties / Responsibilities:

- As the governing body of IFNA, members of the Board of Directors (BOD) shall serve in good faith, uphold the highest professional, ethical, and legal standards, and fulfill the obligations of their positions.
- Perform duties prescribed by the IFNA Articles of Incorporation, and the IFNA bylaws.
- Must attend at least 50% of all BOD meetings per year or will be considered to have vacated their position and a replacement will be named in the next scheduled election.
- Serve in a liaison capacity to at least one standing committee. The Board may participate as ex officio members to all standing committees, except for the Nominating Committee.
- Be informed about the policies and programs of IFNA.
- Participate in the financial development of IFNA.
- Act as an informed advocate and ambassador of IFNA.
- Remain engaged with IFNA communications.
