Agenda Topic:	Approval of prior minutes (S. Meiers)
Motion to Approve	Kathy Knafl moved to approve the March minutes. June Horowitz seconded. Approved.
Agenda Topic:	Financial Board Report (Kathy Knafl) Our upward financial trajectory continues. As of March 31, 2021 our total assets were \$123.510 about 31K more than at the end last month. In March, our income (\$40,050) exceeded our expenses (\$8728) by \$31,321. We are continuing to trend in the right direction!
	This positive financial picture is a function of conference income, including \$48,950 in conference registrations, with almost \$22,000 in conference registrations during March. Clearly lots of people took advantage of the Early Bird Special. We have received \$12,550 in conference sponsorship income, with \$39,500 more pledged. In addition, \$5280 has been contributed to the Pot-of-Gold Challenge. We generated \$6650 in membership dues in March (\$18,765) for the year).

Action:	KME prepared a refined conference budget based on virtual format and need to continue an
	ongoing monitoring of conference budget and expenses. Appreciation expressed to KME for
	continuous monitoring. Kathy Knafl will review carefully and report at May meeting.

A strong slate of candidates was presented to Board from Nominating Committee.

Candidates for Board and Nominating Committee Elections

Conference expenses to date total \$2600, with most of that (\$2008) owed to PayPal. In addition to our monthly fee to KME (\$5500), 0n 4/1 we received the first of four invoices (\$8915 each) to cover KME production costs for IFNC15. The conference budget on which these fees are based had received prior approval from the BOD Executive Committee.

Kathy Knafl seconded motion. Motion carried. Lindsay Smith moved to request the bylaw committee review the stipulation of two-year membership criteria in light of these interpretations. Kathy Knafl seconded. Motion carried.

Discussion:	A productive virtual meeting was held on 15 th March between Sonja Meiers, Kathy Knafl, Veronica Swallow, and Professor Steven Pryjmachuk (member and former President of ISPN https://ispn.memberclicks.net/login#/login) to discuss ISPN's goal of promoting ISPN in and ultimately increasing their membership from countries outside of the USA. We explored and discussed some of the successful strategies used by IFNA over the years to build a truly international membership and Steven is taking these ideas back to the ISPN Board for future discussion. IFNA invited Steven to promote IFNC15, the UK and Ireland Chapter and IFNA membership with his ISPN leadership colleagues and their wider
	membership. Anticipate future productive and mutually beneficial collaborations with ISPN.
