Discussion	Email received for Vigilante Marketing Friday 12/20 At 3:00 PM, we attempted to launch the website, but the initial process did not complete successfully. We immediately contacted our hosting provider's support team for assistance. During their intervention, an unforeseen and serious issue occurred, resulting in the staging site's database being wiped entirely. Unfortunately, this also affected all the work we had done on the staging site. We have confirmed with the hosting provider that their backup system only takes snapshots of the live site's database and not the staging environment, meaning there are no usable backups of the staging site records. Despite our tireless efforts working with their team to recover any data, it has become clear that recovery is not possible.
	We are deeply sorry for this unexpected and unfortunate outcome. Please know that we are taking full responsibility and are committed to rebuilding the website immediately. We estimate

	that it will take us approximately one month to recreate the site and return it to the state it was in prior to this incident.

	This survey aims to map how pre-registration education prepares student nurses worldwide to care for neonates, infants, children, young people, and their families. Hopefully, it will facilitate a better understanding of the education, theory, and practice students undertake to gain the professional registration required to work with this population.
	They have received IRB/ethics approval from their university. I've attached the letter of approval and other relevant documents for the January IFNA Board review. I kindly request the Board's consideration and approval to reach out to IFNA members globally to maximize the survey's reach.
	Suja Somanadhan explained the project and the expectations of IFNA with the project. Elisabeth Coyne noted the ethics approval could be added to ensure clarity. Teresa Gutiérrez-Alemán shared it may be good to share across the chapters and research committee. Suja Somanadhan asked for the board discussion on how to distribute the survey.
